Each homologated body must have an unique EFRA number, even if the same type of bodyshell is already approved for a different manufacturer. **The EFRA number must be set** in an area immediately adjacent to the cockpit, preferably in front of the windscreen, by Touring cars to the right upper edge of the windscreen when looking at the car from above into driving direction. Body homologation number must be visible at time of technical inspection. To prevent other manufactures from copying bodies, it is advised also to emboss the manufactures logo near to the EFRA number on the windscreen. The manufacturer has to retain the example body during the homologation period of five years. If the Homologation Officer suspects that a body has been modified post- homologation he may anonymously purchase an example of the body for checking. If he finds that the body has been modified it will be immediately removed from the approved lists.
