Netherlands June 20th 2015.

Here is the latest news with regards the IFMAR 1/8th IC Track WC in Brasil.

Fuel.

The organizer has contracted 3 brands to supply the fuel for this event.

These companies are:

Byron 2500 Pro Drive = 9% Mix Oil

Tornado On Road 25 = 9% Mix Oil

VP Pro 25 On Road = 9% Oil

We will check for the type of oil, castor and/or synthetic and give the specifications on the organizer's website.

Due to high taxes in Brazil it was no possible to find fuel sponsors, so the fee for the fuel is 60 USD for the official race days (timed practice, qualifying and finals). Drivers will have to make a choice on the brand they want to use on the entry form. These fuels will also be available during the Warm-up race end of July.

Extra cans for the practice are available at shop prices..

Byron 1 gallon US\$ 60,00

Tornado 1 gallon US\$ 55,00

VP Pro 1 gallon US\$ 50,00

The organizer is checking if he can get a better deal on the last prices.

Tires,

The controlled tire will be from Xtreme (Matrix). The price is set at 20 USD per full set (2 front and 2 rear). This means that the fixed price for the race package will be 220 USD (11 sets). These tires will be used for timed practice (4 Rounds), Qualifying (6 Rounds) and your first final. The practice tires will be available at the same price, however drivers are asked to give the number of sets on the entry form, so the manufacturer has an idea on the number of tires he need required.

Entry-fee, fuel and tires.

The total entry fee will include the Standard Bloc Entry fee + 220USD Tires + 60USD fuel).

Customs.

The easiest way to bring your equipment into Brazil is to take it with you in the airplane as personal luggage. Anything sent to Brazil as freight by means of DHL, UPS or another company means you are deemed to pay tax.

Anything you take with you in the airplane is to be considered personal goods and the organizer will provide a letter that you must take with you to show customs when needed. It might be necessary to have a list prepared with all the things you have with you.
