# **Summary of Requirement**

EFRA wishes to contract the services of a Media Partner to cover and live broadcast all the EFRA European Championships indicated below from at least the qualifying day up to the end of each event.

EFRA is seeking for an agreement of three years, starting on April 2016 with an option for EFRA to extend the contract for a further period, under the terms and conditions set out in the media partner contract (see attached). The dates mentioned in the contract are meant as an example, and might vary each year.

The live broadcast should be exposed in such way that it also reaches general public outside the RC Car Community without any charge for viewing.

All commentary should be at least in English language.

The Media Partner must provide pictures, written and video reports on the EFRA Facebook pages and EFRA webpage, and distribute reports to other RC related news pages, RC websites, magazines etc.

Also pictures and information send by the chairmen, should be reported to be published on the EFRA pages, and forwarded to relevant third parties.

The EFRA Logo has to be visible all the time, and the logo of all EFRA Associate Members must be exposed at the beginning and end on the produced video.

All costs related to this agreement is assumed to be handled by the appointed Media Partner and will not be covered by EFRA. The duties of the Media Partner will be under the authority of the relevant EFRA Official.

#### **MEDIA ORGANISATION or COMPANY:**

For the purposes of this agreement:

The EFRA European Championship meetings will be referred to as the EVENTS.

The Press Media Organisation will be known as the PARTNER.

The European Federation of Radio Operated Model Automobiles will be known as EFRA.

agree, that the following terms and conditions will apply to the collaboration agreement for the **EVENTS** detailed below during the calendar year of 2016.

## 1. PRELIMINARY STATEMENTS

**EFRA** sanctions the **EVENTS** in agreement with the corresponding National Association of the host Nations, being the only governing body of the sport of Radio Controlled Car Racing in the host Country which is recognised as such by **EFRA**.

**EFRA** is the only body entitled to endorse the results of the **EVENTS** as official. The **EVENTS** are to be essentially controlled by the **ORGANISERS**, under close supervision of the **NATIONAL RESPONSIBLES** not withstanding final approval of **EFRA**.

The **ORGANISERS** and the **NATIONAL RESPONSIBLES** are legally responsible for the organisation and well running of the **EVENTS** in accordance with its own National Laws, ensuring that a sportsmanlike conduct is maintained. Legal responsibility on the part of **EFRA** is only existing in so far as it appertains as a result of its Constitutional obligation to the National Association and vice versa. Any claim concerning the **EVENTS** can only be made via **EFRA** should the claim be against the National Association and vice versa. the appropriate **EFRA** or National Association Constitutional assembly shall be the only court entitled to give a decision in the case of dispute.

The EVENTS are placed under the exclusive sporting authority of EFRA.

Through the Championship Contracts, the National Associations and any other local organisation under its control assumes full responsibility in all the tasks, duties and responsibilities originated by its contract.

**EFRA** may act at any time before, during or after the **EVENTS** to change any aspect of the **EVENTS** that **EFRA** believes to be either potentially or actively being used in a manner detrimental to the sporting spirit of the **EVENTS**.

Depending upon the character and urgency of the matter **EFRA** may act through either its President, Section Chairmen, Official Delegates, Executive Committee, Board or Annual General Meeting. The decision of **EFRA** shall be final in all cases of interpretation of the rules.

## 2. SCOPE OF THIS AGREEMENT

Both parties are interested in the promotion and development of the SPORT of Radio Controlled Automobiles, with **EFRA** as the major International body organising events and the **PARTNER** as one of the recognised specialist media for the sport. Both parties with common interest are committed to collaborate for these EFRA EC events.

# 3. COMMITMENTS

An unique single **PARTNER** will attend the event from the first racing day and assumes the obligation of compiling at least one **EFRA REPORT** each day in English language, with pictures and video to be published on the EFRA web page, EFRA social media, and distribute reports to other RC related news pages, RC websites, magazines etc. If he wishes so, also on his own page at the same time.

Also pictures and information send by the chairmen, should be reported and to be published on the EFRA pages, and forwarded to relevant third parties.

The **PARTNER** assumes the obligation to display an **EFRA** logo on every video he produces of the events and to include an **EFRA** watermark logo on every picture he displays of the event, either at his web page or on the **EFRA** Web page. The logo of all EFRA Associate Members must be exposed at the beginning and end on the produced video.

**EFRA** will supply the **PARTNER** with a confidential pass-code for the purpose to login to the **EFRA** web site and Social media pages, to upload pictures and videos that will remain the co-property of **EFRA** for future promotion purposes, but never for commercial purposes.

The **PARTNER** will contact the **Organisers** when needed to agree any special internet access required track side for developing his duties.

**EFRA** in turn assumes the obligation of a financial support for the attendance of the **PARTNER** to the events, the amount of such is the sum of ...... including all taxes, as determined by the EFRA BOARD following instructions of the **EFRA** AGM.

# 4. ETHICS, PARTNER IMAGE, EFRA IMAGE AND ORGANISERS IMAGE

The whole collaboration of this agreement is based on the adequate promotion of International racing. Consequently correct English language must be used with an unbiased International focus with an equal treatment of possible commercial interests involved. Competitors from all countries must receive similar portrayal and likewise for manufacturers and their equipment used at the **EVENTS**.

The image of **EFRA** and that of the **ORGANISERS** must always be treated in a positive way, in order to promote International racing and the Events, always with strict respect of the freedom of speech and opinion.

The **PARTNER** shall not have exclusive rights over the coverage and image of the Events, but his production will be displayed on the EFRA web page with rights to include a link to his own web page. His logo will appear on the **EFRA** web page as media **PARTNER** of the **EFRA** events and he is authorised to display during the corresponding year a purpose made logo furnished by **EFRA** indicating his involvement.

## 5. PENALTIES AND SANCTIONS

**EFRA** may decide to levy appropriate sanctions or financial penalties, which will not exceed the sum of 40.000 € if the **PARTNER** does not fulfil all of the obligations constituting this agreement.

### 6. DISCLAIMERS AND LIABILITY

**EFRA** will in no event be liable for lost profits, lost savings or other consequential damages even if any other party has advised them of the possibility of such losses or damages or for any claim against the **PARTNER**. Obviously the **PARTNER** is solely responsible for his people, costs and material used.
