Please, BE FAST NOW, adjustments can be made, but we need the information to proceed with the preparation of the events.

The second issue is just a **CLARIFICATION**, mostly using your common sense it can be crystal clear, but in order to avoid any confusion and to help you to attend our meetings with the proper material, I must make clear that the rules 3 related to Batteries at Appendix 3 of the EFRA Handbook 2017, page 126 to 129, are fully applicable to our Electric Cars, i.e. dimensions, voltage, charging procedures etc and more specifically the rule 3.7:

**“3.7 Only batteries appearing on the Official EFRA website will be legal for use in EFRA sanctioned meetings”**

This clarification will help the growing and attractive Electric 8<sup>th</sup> Buggy EFRA Open EC (probably our last time at this format) This is going to be on the very first weekend of September, from 1 to 3 September, at Velika Gorika, by the Zagreb Airport.
