Points to be considered:

1. **RULES:** IFMAR WC will be race under IFMAR rules. At the moment we don't expect any other changes, but if IFMAR approves a new version of the rules, we will keep you informed. Check the link:

2. **Bodies:** IFMAR will provide a new homologated body list during 2019. No other Bodies will be allowed in World Championship.
3. **Tires:** IFMAR WC Championship will be raced with a one brand Controlled tire.

Registration: The dates provided by IFMAR for both events are early 2020, (less than 2 months after AGM 2019). Allocations for both races need to be done before the AGM.

It's for that reason, we are going to open an exceptional registration procedure.

All drivers/federations who are interested to attend for an event, can register on the EFRA website.

The fee for the event will be same as IFMAR WC (see Handbook 2019) and procedure for payments will be handled through the Federation.

As always, your Federation still has to approve a registration made by a driver for a World Championship.
