Good afternoon everyone, please see the regulations for the EC B Tires 2025:

Tire Instructions & Procedure – EFRA E.C. B 2025

We are introducing a new tire system for the EFRA EC B 2025.

1. BRAND Entry Procedure

Any tire manufacturer (hereafter referred to as **BRAND**) may enter to take part in the event.

Participation requires:

1. A **single, one-time payment of €250** from each BRAND to the Organizing Club, **Ospy Team**, as a contribution to the system.
2. The selection of **one unique tire profile** (any compound, any insert) per BRAND, to be used at the event.

Only one profile design per BRAND is allowed.

Both requirements must be fulfilled by **6th July 2025**, more than two months ahead of the event scheduled for **12–14 September 2025**.

2. BRAND Tire Commercialisation

Each BRAND will decide:

- The cost of their selected tires with complete wheels.
- The method of commercialisation (e.g., via shop, distributor, or directly by the BRAND trackside).
- Pricing for drivers (e.g., regular pricing, free, or discounted).

All such decisions are at the discretion of each BRAND.

3. Driver Tire Control System

To ensure fair competition, each driver must contribute **€1 per tire** (i.e., **€4 per complete set of 4 tires**) to the Organiser for **marking and control**.

To streamline this process:

- Each of the **156 driver badges** will include **5 checkered positions**, corresponding to 5 sets of tires.
- Upon arrival, **each driver will pay €20** to the Organizing Club, **Ospy Team**, to cover the marking of 5 sets of tires.

- This payment gives the driver the right to register and use **5 complete sets of marked tires** during the event
- **The €20 fee covers only the tire marking and registration.** The cost of purchasing tires is separate and set by each BRAND.

This payment must be made **in cash at the track** or **in advance via PayPal** to info@ospyteam.com, clearly marked as a **Friends and Family** transaction.

4. Additional Sets for Finals

We are allowing **5 tire sets per driver** as standard for this event.

Additionally, any driver who:

- Advances to a final beyond their first (e.g., from semi-final to main final), or
- Enters an **exhibition final**,

...will have the right (but not the obligation) to **purchase and mark one extra set of tires** for **each such additional final**. Each extra set will cost **€4** for marking and must be paid and registered accordingly.
